Select Entry Permit Type

Transit Visa (€30.00 golles)

Valid for 2 days, for passing through Mount Vema to a third destination.

Tourist Visa (€140.00 golles)

This visa is issued for 30 days of leisure travel, no business activities Allowed.

Business Visa (€100.00 golles)

This visa is issued for engaging in commerce in Mount Vema for 3 months, 6 months or 12 months. This type of visa precludes permanent employment, for which a work visa would be required.

Spousal Visa (€40.00 golles)

This visa is granted to the spouse, civil partner or de facto partner of a resident or citizen of a given country, in order to enable the couple to settle in Mount Vema.

Student Visa (€30.00 golles)

This visa allows the holder to study at an institution of higher learning in Mount Vema.

Working Holiday Visa (€50.00 golles)

This type of visa is for individuals traveling between nations offering a working holiday program, allowing young people to undertake temporary work while traveling.

Courtesy Visa (€160.00 golles)

This visa is issued to representatives of foreign governments or international organizations who do not qualify for diplomatic status but do merit expedited, courteous treatment.

Marriage Visa (€90.00 golles)

This type of visa is granted for a limited period prior to intended marriage or civil partnership based on a proven relationship with a citizen of Mount Vema. This type of Visa is valid for three months from the date of its approval.

Retirement Visa (€40.00 golles)

This type of visa is issued to those who can demonstrate a foreign source of income and who do not intend to work in Mount Vema. Age limits may apply in some cases.

Airside Transit Visa (€15.00 golles)

Required for anyone passing through the seaports or airports of Mount Vema, despite the need of not going through immigration clearance.

Diplomatic Visa (€100.00 golles)

This is an official visa, issued to bearers of diplomatic passports.

Temporary Worker Visa (€80.00 golles)

This visa is issued for employment in Mount Vema for 1 year, 2 years or 3 years, and includes scientific/research work.

On-Arrival Visa (€220.00 golles)

This visa is granted at a port of entry. This is distinct from not requiring a visa at all, as the visitor must obtain the visa before trying to pass through immigration. It has to be very special circumstances and is not recommended.

Crew/Seaman Visa (€80.00 golles)

This type of visa is issued to crew members of shipping companies, international airlines and to aliens required for the normal operation and service of a vessel or an aircraft. In the case of a ship, in determining who qualifies for this type of visa, the individual's responsibilities and activities on the ship is taken into consideration.

Journalist Visa (€110.00 golles)

This type of visa is required of journalists when traveling to Mount Vema for their respective news organizations.

Immigration Visa (€140.00 golles)

This is a visa granted for those intending to immigrate to Mount Vema. This type of Visa is issued for a single journey as the holder would later be issued a permanent resident identification card which will allow the traveler to enter to the Kingdom of Mount Vema on unlimited number of times.

Diving/Landing Visa (€10.00 golles)

For cruise ship passengers, who are not formally leaving the ship, and intend a few hours of diving or sightseeing only.

Processing Time

Express (With a fee of €150.00 golles)

Visa applications may take at least 30 days to 90 days to process. If you need a Visa within two weeks, there is an additional processing fee which is €150 golles in addition to the actual fee. Enter Yes or No.

- 1-By submitting this form, I acknowledge that, if there is a material change in my circumstances or new information relevant to this application, I will inform the Department of the Government of Mount Vema which I am submitting this for to.
- 2 – I am aware that it is an offence to make a statement which I know to be false, or not believe to be true.
- 3 – I have and I will have sufficient finance to sustain myself during my time in Mount Vema.
- 4 – I will abide by any of the conditions that is imposed on my Entry Permit, and the laws, rules, orders and regulations of the Kingdom of Mount Vema.

5 – I understand that I will commit an offence if I do not leave Mount Vema on or before my Entry Permit expires and if I remain in Mount Vema I may be prosecuted and or deported.

6 – I have not tried to obtain Entry into Mount Vema by fraud, false representation or concealment of any material fact.

7 – I understand that a Mount Vema entry visa is subject to an Exit Visa required when leaving the Kingdom.
